Notwithstanding any other provision of this articles, the corporation shall not carry on any other activities not permitted to e carried on (a) by a corporation exempt from federal income tax under section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c) (2) or the Internal Revenue Code, or the corresponding section of any future federal tax law.


