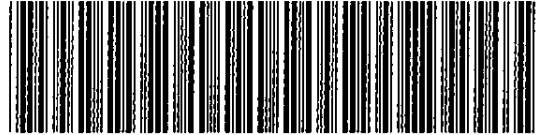

ARTICLES OF INCORPORATION
OF
US4CHILDREN A NON-PROFIT FLORIDA CORPORATION

The undersigned, natural person, of the age of eighteen years or more, acting as the organizer of a non-profit company under the Florida Non-Profit Corporation Act, adopts the following articles of organization for such Non-Profit Corporation.

Article I

NAME OF NON-PROFIT CORPORATION: The name of this non-profit corporation shall be US4CHILDREN INCORPORATED.

Article II

PRINCIPAL OFFICE: The principal street address and mailing address is: Paul Douglas Boles, 116 Bimini Cay Circle, Vero Beach, Florida 32966.

Article III

STATEMENT OF PURPOSES: The purpose of which this corporation is organized are to improve the lives of children in the United States of America (USA) by networking using the Internet; talks with churches, groups and corporations; and to build an account that will assist children in need in the USA.

Article IV

MANNER OF ELECTION: Those people named in the Articles of Incorporation as directors and/or officers shall hold office and comprise the Board of Directors for a term of two (2) years or in perpetuity. At the death of a board member, the remainder of the board will meet and appoint someone to fulfill the position made vacant. Positions later deemed necessary will be fill by a consensus of the board and shall serve for a term of (2) years.

Article VIII

PERIOD OF DURATION OF THE NON-PROFIT CORPORATION: The period of duration of the corporation shall be perpetual.

Article IX

MEETINGS: Meetings shall be held on a quarterly basis with all board members in attendance, whether physically or by conference calling. Special meetings of the board shall be held when called for by the President of US4CHILDREN INCORPORATED, after notice to all board members.

Minutes will be taken at all meetings of the Board of Directors and shall be kept on file for seven (7) years.

Article X

DISSOLUTION: In the event that US4CHILDREN INCORPORATED should dissolve, distribution of assets will be in compliance with Florida State Law for Non Profit Corporations. All assets remaining will be for the purpose of charitable distribution.

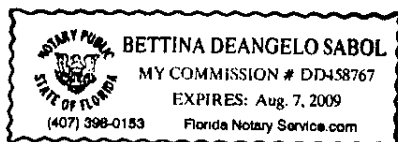
