ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporators a corporation pursuant Florida Corporations Law Statue 617 governing non-profit corporations, adopts the following Articles of Incorporations.

ARTICLE

NAME

The name of corporation shall be:

ARTICLE III

PURPOSES

Specific purposes of the corporation areas follow:

- 1. Development of programs designed to promote motorcycle riding and the networking on motorcycle organization and individual motorcycle riders and owners.*
- 2. To promote, educate and expand safe operation of motorcycles.*
- 3. To engage in the community development projects designed to improve the quality of life of the economically and socially disenfranchised.*
- 4. The purpose for which the corporation is organized are exclusively charitable and educational within the meaning of section 501(c) of the Internal Revenue Code of 1986 or any corresponding provision of any future United States Internal Revenue Law.*
- 5. To engage in any other legal business necessary to the achievement corporate goals and objectives.*
- 6. To development and implement programs to build sound moral value systems.*

ARTICLE IV

DISSOLUTION CLAUSE

Upon dissolution of the corporation either as an act of law or by resolution of the Board of Directors assets of the corporation will be distributed to a non-profit 501 (c) ((3) corporation. "However" if the named recipient is not in existence or is no longer qualified as a distribute, or unwilling to accept the distribution, the assets of the organization shall be distributed to a fund, foundation, or organization which is organized and operated exclusively for purpose specified in section 501(c) (3) of the Internal Revenue Code.

ARTICLE V

LIMITATION OF POWERS

Notwithstanding any other provision of these articles the organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under 501 (c) (3) of the Internal Revenue Code 1986 or any correspondence provision of any United States Internal Law.

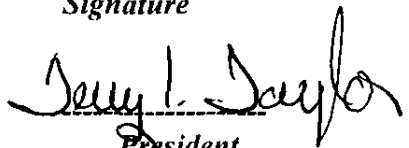

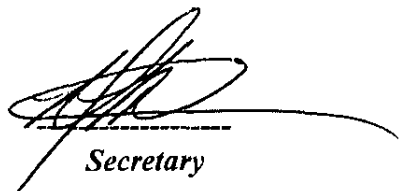

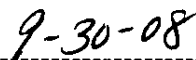
