ARTICLE OF INCORPORATION
FOR
ASOCIACION EVANGELICA INTERDENOMINACIONAL
EL GRANERO DE DIOS, CORP.

The undersigned, acting as incorporator(s) of a Corporation pursuant to chapter 617 Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be: ASOCIACION EVANGELICA INTERDENOMINACIONAL EL GRANERO DE DIOS, CORP.

ARTICLE II PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of Business and the mailing address of this Corporation shall be:
15741 SW 100th AVENUE MIAMI, FL 33157.

ARTICLE III PURPOSE(S)

The specific purpose(s) for which the corporation is organized is (are) : **NON-PROFIT ORGANIZATION**, to serve as a link/liaison to religious public, private, government and state entities and community base organization for the good societal development, promoting the self-sufficiency of the participant sectors through specific programs, in order to instruct and to enable spiritual and secular education to leaders workers and pastors of Churches and to the participant communities according to the rules and precepts of our Lord Jesus Christ.

In order to fulfill the purposes indicated, the organization will have the ability and capacity:

- a. To contribute in the formation and training of leaders.
- b. To Channel financial aid and logistics, agricultural and industrial machineries, medical equipment and materials, agricultural and industrial consumables, construction, equipments etc.
- c. To develop agricultural and stockbreeder projects well as agribusiness, that serve as self-support and training for the participant sectors.
- d. To promote the building development of schools, institutes, seminaries, universities health centers, orphanages, churches, for education and preparation.
- e. To promote and to create projects in the telecommunication area (i.e. radio, television, etc).
- f. To promote the development of centers in the childhood area, youth affected by family abandonment and by vices (bad habits), like drugs, alcoholism, gangs and corruption like prostitution and child pornography .
- g. To promote the development of centers for the abused women (domestic violence) developing training programs in agro-industrial area (agribusiness) as well as in the handcraft/craftwork area, according to each necessity.
- h. To promote development of centers so-called "House/Home", for pastors and pastors widows of the graving population, living in poverty and that have been neglected by their city and county council.

- i. To promote the development of sport center for children, youth and adult population.
- j. To promote development of regional missionary centers, that serve as a base of logistics and missionary program trainings, national as well as international.
- k. To promote the development of workshop, polls, symposiums on a national level as well as the foreigner level, between population and organisms areas as much as state-owned as private-owned.
- l. To promote and to establish interchange and cooperation spaces between organisms and homologous institutions and its related fields, national and international, state and private institutions, those considered appropriate and those who go in accordance to the association measures
- m. To promote the development and unity among churches and participant organization in accordance to our Lord Jesus Christ's principles and teachings.
- n. To receive, accept and affirm under our coverage, organizations and its affiliates, both at a national level as any port of the world, as long as they share the same spirit and character that ASEINGRAD does.
