The Board of Directors, upon dissolution of this corporation, in accordance with the laws of Florida governing dissolution of not for profit organizations, and organizations exempt from federal income tax under Section 501(c) of the Code, or the corresponding provision of any subsequent federal tax laws, shall distribute all of the corporation's assets remaining, after paying or making provision for the payment of all liabilities of this corporation, exclusively to corporation organized under the laws of the state of Florida as not for profit corporations, and corporations which have qualified for exemption under either Section 501(c)(3) or Section 501(c)(6) of the Code, or corresponding provisions of any subsequent federal tax laws, and none of the net earnings or assets of this Corporation shall be distributed to any individual or any member, Director, or officer of the corporation.

ARTICLE 8 MISCELLANEOUS

1. No part of the net earnings or assets of the corporation shall inuse to the benefit of any individual or any member, director or officer, of the Corporation, except that the corporation shall be authorized and empawored to pay residuable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 2 hereof.
