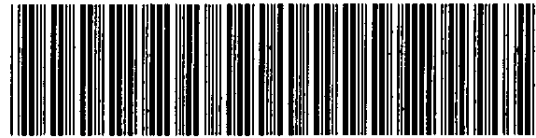

I, the undersigned incorporator, file with the Secretary of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation not for profit in accordance with the laws of the State of Florida.

ARTICLE I Name

The name of this corporation shall be: KRUSH SPORTS & ENTERTAINMENT, INC. (a.k.a. KSE, Krush Sports or Krush Entertainment)

ARTICLE II Principal Office

The principal place/address of business of this corporation shall be 31178 Cortez Blvd. #101, Brooksville, Florida 34602 or such other address within the State of Florida as the Board of Directors may from time to time designate.

ARTICLE III Purposes

The purpose of the organization is to produce sportsmanship awareness and mentors for youth by providing sporting activities.
