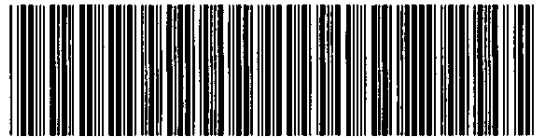


Action for Dissolution by Board of Directors


