Article of Incorporation Of Jewish Restoration Organization

Article of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of <u>Florida</u>, do hereby certify:

Article I Name of Corporation

The name of the Corporation shall be Jewish Restoration Organization, Corp.

Article II Principal Place of Business

1001 West Cypress Creek Rd. Suite 302P Fort Lauderdale, FL 33309 The office is located in Broward County, Florida.

Article III Purpose

Said corporation is organized exclusively for Jewish Restoration Projects. Jewish Restoration Organization is dedicated to the development, investment and disbursement of charitable funds to restore and preserve historical Jewish sites by providing for the maintenance and continuity of Jewish Sites. These sites include but are not limited to; Jewish Cemeteries and Jewish Synagogues. The disbursements of such funds will be for educational and historical purposes as well as community human needs projects and programs.

The restoration project for which said corporation is organized shall be the carrying on of the following:

To Honor the dead in accordance with Jewish religious practices, traditions, and beliefs.

To provide for continuity of operation

Maintenance and security of existing and abandoned cemeteries and Synagogues

Continuity of leadership in managing and operating Jewish Cemetery Associations

Responsible administration of the endowment care fund for perpetual operation of Jewish Cemetery and Synagogue Associations.

Joint communal activity for Jewish Cemeteries and Synagogues, to foster, develop, coordinate and participate in joint planning of activities and programs among our members.



Preservation and restoration of Jewish Cemeteries and Synagogues, including the preservation of assets, archives and records.

Article IV Manner of Election

The Board of Directors shall be Members nominated and elected in the manner specified herein and in the Bylaws. The Board of Directors shall have control over the property and affairs of the corporation. It shall establish policy of the corporation. Such officers shall carry out the mandates and directives of the Board of Directors, and shall perform such duties as the Board of Directors shall determine.

Article VIII Net Earnings

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting, to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted

to be carried on

(a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), or

(b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

Article IX Dissolution

Upon dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any of such assets not so disposed of shall be disposed of by the United States District Court for the state of Florida, exclusively for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes.

Having been named as registered agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity.
