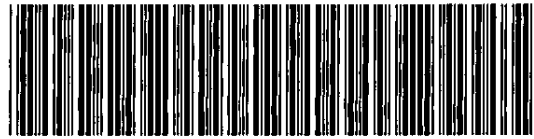

**ARTICLE I: NAME**

The name of the corporation shall be: International Universities Bureau, Inc.

**ARTICLE II: PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be: 5256 N University Dr #58010140, Lauderhill, FL 33351.

**ARTICLE III: PURPOSE**

The fundamental purpose is to serve, help and give services to companies, organizations, community associations, educational institutes of any kind, and persons belonging to social classes in need, for the Education of people, either of the working class, the poor or other social class, to convert them in better citizens; distribution of food, clothing, footwear, medicines and endowments; within these primary purposes, with a non-profit can serve to others through the purchase, sale and rental of Audiovisual equipments, tools for teaching, support materials and various task items. The company may, in turn, fulfilling the requirements laid down in law, build and manage educational campus, and provide educative services to Institutes of Basic Education, High School, School of Vocational, Technical Schools, graduate and undergraduate Education (University), Agricultural Education, Continuing Education, handicap Special Education, Adult Education, Education for the Arts, School of liberal Education and Distance Learning. may also build and manage homes for the care and shelter for destitute or abandoned children and elderly. The company can run, always within the regulations established by Laws, any other activity "Non-profit" linked to the above, which constitute the essential purposes.

#### **ARTICLE IV: ELECTION OF DIRECTORS**

The manner in which the directors are elected or appointed will be appointed according to the Bylaws of the corporation.

This Corporation is organized and operated exclusively for charitable purposes within the meaning of Section 501(c)(3), Internal Revenue Code.

#### **ARTICLE VIII:**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### **ARTICLE IX:**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

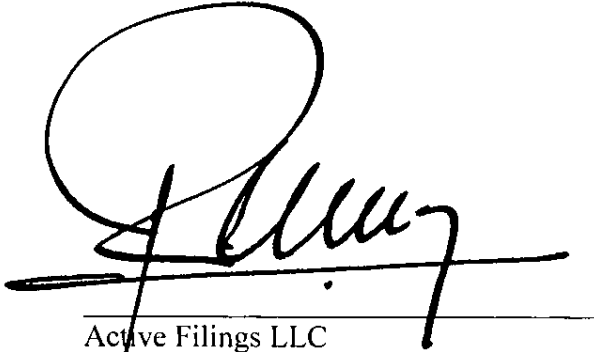

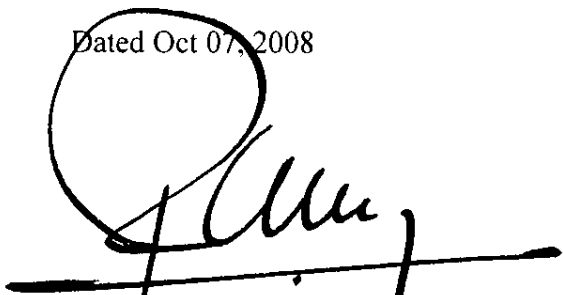
