## ARTICLES OF AMENDMENT OF THE ARTICLES OF INCORPORATION OF BONITA GRANDE COMMERCIAL CONDOMINIUM OWNERS' ASSOCIATION, INC.

The Articles of Incorporation of Bonita Grande Commercial Condominium of Owners' Association, Inc., filed in the office of the Florida Secretary of State on 14, 2008, as document number N0800009521 are hereby amended as follows:

### I. PREAMBLE

The Preamble of the Articles of Incorporation is hereby amended in its entirety to read as follows:

FRP, LLC, a Florida limited liability company, (hereinafter referred to as "FRP"), owns certain property in Lee County, Florida (the "Property"), and intends to execute and record a Declaration of Condominium, Covenants and Restrictions (the "Declaration") which will affect the Property. FRP, LLC, together with The Vetter Company, shall be referred to collectively herein as the "Developer"; although, pursuant to its contract with FRP, LLC, The Vetter Company shall assume all responsibilities for the development of the Property.

The Association is being formed to administer the Declaration, and to perform the duties and exercise the powers pursuant to the Declaration, as and when the Declaration is recorded in the Public Records of Lee County, Florida, with these Articles of Incorporation attached as an exhibit. All of the definitions contained in the Declaration shall apply to these Articles of Incorporation, and to the Bylaws of the Association.
