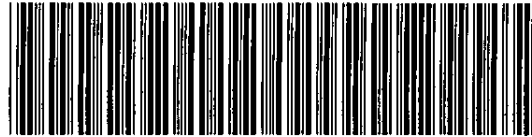

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I: The name of this not-for-profit corporation shall be the Cultural and Social Development Center for Adopted Children, Incorporated.
