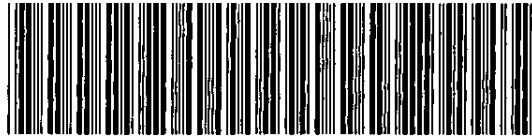

### ARTICLE I NAME

The name of the corporation shall be: **Rainbow Ladies - Our Space, Incorporated.**
