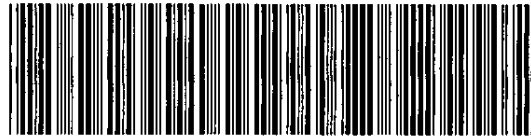

Purpose: The NAAHR, South Florida Chapter, Inc. is organized exclusive for charitable and educational purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. This organization's membership is open and nonrestrictive. This organization will provide leadership on issues affecting individual careers and the global workforce. This organization will solicit donations to offer awards and scholarships for educational pursuits. It will focus on providing a forum where African American human resource practitioners and anyone aligned with its goals can share and gain information.

SECTION 7. Dissolution Clause. Upon the dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

This corporation is organized exclusively for educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future United States Internal Revenue law.

Upon the winding up and dissolution of the corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
