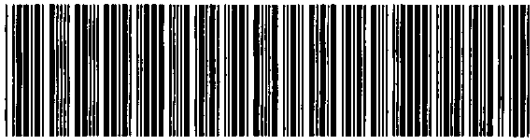




Amendment
