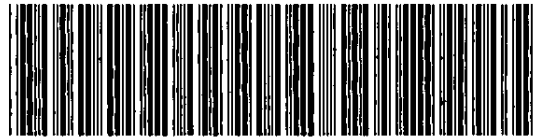

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF
SK SISTERS SUBDIVISION HOMEOWNERS ASSOCIATION, INC.
A NON-PROFIT FLORIDA CORPORATION

Pursuant to the provisions of FS §617.1001 and FS §617.1002, the undersigned corporation submits the following articles of amendment:

1. The name of the corporation is: SK SISTERS SUBDIVISION HOMEOWNERS ASSOCIATION, INC.
2. The following amendments to the articles of incorporation were adopted by the members of the corporation, joined by the Developer, on the 22nd day of December, 2008:

Subparagraph (i) of Article III shall read "The Association shall operate and maintain common property and such other property for which an easement recorded in the public records of Polk County, Florida reserved for the use, control and management of the Association, specifically the surface water management system facilities, including all inlets, ditches, swales, culverts, water control structures, retention and detention areas, ponds, lakes, floodplain compensation areas, wetlands and any associated buffer areas, and wetland mitigation areas."

Subparagraph (l) shall be added to Article III that reads "The Association shall have all the applicable powers set forth in Section 617, F.S."

Article XII shall be amended to read "The Association shall exist perpetually; however, if the Association is dissolved, the control or right of access to the property containing the surface water management system facilities shall be conveyed or dedicated to an appropriate governmental unit or public utility and that if not accepted, then the surface water management system facilities shall be conveyed to a non-profit corporation similar to the Association.

3 The above-stated amendments shall become effective on the date these Articles of Amendment is filed and accepted by the Florida Department of State, Corporations Division.




