



16.) What is the purpose for which the organization is organized?

Kitty Cat Connection, Inc. will provide a safe, healthy place for abused, abandoned, and feral cats to live out the rest of their lives. We also will take in kittens and provide them with medical care and search for homes for them to be adopted into. We are also involved in TNR in the hopes of slowing down the abandoned kitten population. We provide a safe place for these animals knowing that they will never want for anything for the rest of their natural lives.

We provide shelter, medical care, food and water for all kittens and cats. We will also rescue abused or abandoned cats. The cats that we take in are spayed/neutered and micro-chipped prior to their adoption. The cats that are un-adoptable live in a home roaming free with no cages. Every cat feral or tame receives shots and deworming, also. Kitty Cat Connection will have land where the cats and kittens will be housed and we hope to grow and expand as we become better known. We have a veterinarian we work with that is as good with feral cats as well as with domestic cats.

Kitty Cat Connection, Inc. will take in and rescue feral, wild and abandoned cats and from people that can no longer take care of their pets. We will find suitable homes for the cats and kittens that we feel are adoptable. We will both pick up the cats and people will bring the cats to us.
