ARTICLE I

The Name Of This Corporation Is: Hope Abounds Ministry, Inc.

ARTICLE II

The Term Of This Corporation Is Perpetual.

ARTICLE III

Purposes

The general nature, objective and purpose of Hope Abounds Ministry, Inc. IS:

- (a) For the purpose of promoting, establishing, and administrating a local Body Of Believers (local church body), with all matters pertaining to Church worship, fellowship, teaching and training Church Membership with Missionary Outreaches, Religious Seminars, Church Officers, Church Government and Church Operation to be determined and stated in By-Laws of the Corporation hereinafter authorized by these Articles Of Incorporation.
- (b) To participate and conduct Christian Outreach and Evangelism Programs.
- (c) Hope Abounds Ministry, Inc. shall be wholly a Charitable Organization.
- (d) To acquire by conveyance or inheritance—whether by gift or purchase---real property, personal property and mixed real and personal property, to be received and held in trust for the use and benefit of this corporation and its stated purposes.
- (e) To improve, invest, sell, lease, assign, mortgage, or otherwise encumber any such property, when such action is deemed to be in

- the best interest of this corporation as defined in its' stated purposes as a Christian Organization.
- (f) To market tapes, books and gospel materials printed by said corporation for funding and furthering the Gospel.
- (g) To operate and manage Radio and T.V. outreach and stations.
- (h) To solicit funds for each special project concerning the ministry on an organized giving plan.

ARTICLE IV

- (1) To accomplish the foregoing purposes, Hope Abounds Ministry, Inc. shall have all corporate powers permitted under the laws of the State Of Florida, including the legal capacity—as an independent entity—to enter into contracts and to prosecute and defend against actions at law and equity.
- (2) The Corporation is specifically precluded from engaging in any Prohibited activities, as defined in Section 617.0105 of the Florida Statutes.

ARTICLE V

QUALIFCATION OF MEMBERS

The membership of Hope Abounds Ministry, Inc. shall be limited to Born-Again Christians of the Spirit of God and must be persons of Christian convictions and beliefs who have been spiritually baptized in The Name of The Father, The Son and The Holy Spirit and been accepted into membership of this organization by a majority vote of the membership of this Corporation. Anyone may attend worship services, but membership is reserved for those who meet the requirements. A candidate for membership must believe in the doctrine of the Holy Bible which is the belief and doctrine and of Hope Abounds Ministry, Inc. The member must abide by the rules and regulations placed upon them by the By-Laws of this Coroporation and the Word Of God. Membership can be terminated by proper vote of the membership majority and the Board of Directors. Membership is not required to attend scheduled services.

- (a) Hope Abounds Ministry, Inc. shall license and ordain ministers to preach the Gospel and carry out the duties of an ordained minister as to the Body of Christ at large.
- (b) Hope Abounds Ministry, Inc. shall also operate as a Fellowship of Ministers and Churches as set forth in our By-Laws.

- (b) Notwithstanding any other provision of these Articles, this Corporation will not carry on any other activities not permitted to be engaged in by:
- (1) a corporation exempted from Federal Income Tax under sections 501c3 of the Internal revenue Code of 1954 or the corresponding provision of any future U.S. Internal revenue Law; or:
- (2) a corporation, contributions to which are deductible under section 170c2 of the Internal revenue Code of 1954 or any other corresponding provision of any future U.S. Internal revenue Law.
- © In the even of dissolution, the residual assets of this Corporation will be turned over to a duly authorized Not-For-Profit Organization of the choice of

the Board Of Directors/Trustees, one that falls within the guidelines of the sections 501c3 and 170c2 of the Internal Revenue Code of 1954 or the corresponding sections of any prior or future law.
