ARTICLE 1: Name and Principal Office

The name of this corporation shall be: Xpress Youth Sports Club, INC.

ARTICLE 2: Principal Office

The principal place of business and mailing address of this corporation will be 2396 Foliage Oak Terrace, Oviedo, Florida, 32766.

ARTICLE 3: Purpose

The purpose of XPRESS YOUTH SPORTS CLUB shall be to promote, develop, and administer sporting events for its youth members, whom are under nineteen years of age, and to promote regional, state, and nationwide amateur competition for its members as a qualified amateur sports organization.

XPRESS YOUTH SPORTS CLUB will be a tax-exempt organization under the laws of the United States, and shall maintain its tax-exempt status. It is organized to benefit minors in accordance with section s.212.08(7)(I), F.S. Accordingly, XPRESS YOUTH SPORTS CLUB will solicit contributions from the public in the State of Florida and will register with the Division of Consumer Services.

XPRESS YOUTH SPORTS CLUB is a corporation that does not contemplate pecuniary gain or profit to the members of the Board of Directors or club participants and is organized solely for not-for-profit purposes.

ARTICLE 4: Manner of Election

At the time of company formation, the incorporator will appoint the corporate officers. The corporate officers of President, Vice President, Secretary, and Treasurer shall be members of the Board of Directors, with the President acting as the Chairman of the Board. The corporation has elected not to have members with voting privileges per statute. All youth members, coaches, parents/guardians and other individuals associated with the company and its functions who are not members of the Board of Directors are deemed to be participants in the company's activities and have no voting rights. Participants in the company's activities will be determined by the President and Vice President. The President and Vice President will be appointed for a period of 5 years. Other Officers will be appointed for a period of 1 year. All officers will be re-elected by a majority vote of the board. An officer cannot vote for themselves. Any changes to the board will be based on a majority vote by the board.

The period of duration of this nonprofit corporation is perpetual.
