The Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation of the State of Florida, do hereby certify:

First: The name of the Corporation shall be NORTH GREENWOOD COMMUNITY COALITION, INC.

Second: The place in this state where the principal office of the Corporation is to be located is in the city of Clearwater, Pinellas County.

Third: Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c)3) of the Internal Revenue Code or the corresponding section of any future federal tax code.

Further, said corporation has as a mission purpose to free our community of drugs and crime through persistence, education, recreation, mentoring, crime prevention, employment and religion. Sixth: Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
