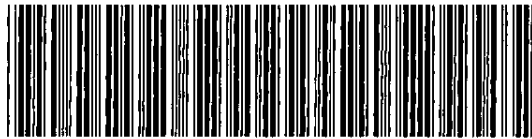

### **ARTICLE I NAME**

The name of the corporation shall be: **HOLY SPIRIT INTERNATIONAL EVANGELISTIC MINISTRIES, INC.**

### **ARTICLE II PRINCIPAL OFFICE**

### **ARTICLE III PURPOSE**

#### **ARTICLE IX ACTIVITIES**

Notwithstanding any other provision of these articles or subsequent amendments to these articles, this organization shall not carry out any activities not permitted to be carried out by any organization exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code or the corresponding provision of any future federal tax code.

#### **ARTICLE X INUREMENT**

The Corporation is not formed for and shall not be conducted nor operated for pecuniary profit or financial gain, and no part of its assets, income or profit shall be distributed to or inure to the benefit of any private individual or individuals (including member, trustee or officer of the corporation), provided that nothing herein shall prevent the Corporation from paying reasonable compensation to any person for

services rendered to or for the Corporation in furtherance of one or more of its purposes.

#### ARTICLE XI DISSOLUTION

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose subject to the approval of a Justice of the Supreme Court of the State of Florida.
