AMENDMENT TO ARTICLES TO ARTICLES OF INCORPORATION OF COMPASSIONATE VOLUNTEER ALLIANCE of BREVARD, IN Pursuant to the provisions of Section 617.1006, Florida statues; this FLORIDA NOT FOR PROFIT CORPORATION adopts the amendment to its Articles of Incorporation: ARTICLE III. PURPOSE Purpose #1 of this Article is amended as follows:
