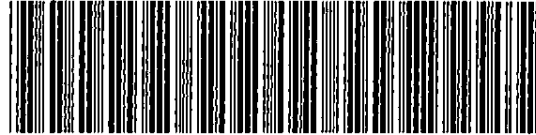

**ARTICLES OF INCORPORATION
FOR
INTERNATIONAL GYMNASTICS BOOSTER CLUB, INC.**

Articles of Incorporation of the undersigned, a majority if whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

Article 1- The name of the corporation shall be International Gymnastics Booster Club, Inc.

Article 2 – The principal office is located in Miami-Dade County and the mailing address of the Corporation is

Article 3 – The corporation is organized exclusively for charitable purposes, fostering national and international amateur gymnastics competition, including, for such purposes, the making of distributions that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article 5 – The initial Registered Agent for the corporation is Stuart Serrott, whose address is 11391 SW 122 Street, Miami, Florida 33176

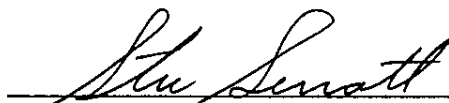

Article 6 – No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 3. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Article 7 – Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
