Article I., Name

The name of the corporation shall be **Homework Assistance & Tutoring Service**Inc.

Article II., Principal Office and Mailing Address

The principal place of business of this corporation shall be 11269 N. Main Street, Jacksonville, FL 32218. The mailing address shall be 1115 Turtle Creek Drive South Jacksonville FL 32218

Article III., Purpose

H.A.T.S., Inc. is organized exclusively for charitable, religious, educational and/or scientific purposes, including, for such purposes as the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
