Article I., Name

The name of the corporation shall be **Homework Assistance & Tutoring Service Inc.**

Article II., Principal Office and Mailing Address

The principal place of business of this corporation shall be 11269 N. Main Street, Jacksonville, FL 32218. The mailing address shall be 1115 Turtle Creek Drive South Jacksonville FL 32218

Article III., Purpose

H.A.T.S., Inc. is organized exclusively for charitable, religious, educational and/or scientific purposes, including, for such purposes as the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article IV., Manner of Election of Trustees/Directors

The corporation shall have up to fifteen (15) Trustees/Directors. The number Trustees/Directors may be increased or reduced from time to time as provided in the By-Laws of the corporation. However, as provided in the By-Laws, the corporation shall at all times have at least five (5) Trustees/Directors. The initial Board of Trustees/Directors shall be approved by the chief executive officer. Subsequent Boards of Trustees/Directors shall be elected by a majority of the full Board at its annual meeting or as otherwise provided in the official corporate By-Laws. The initial Board of Trustees/Directors is as follows:

Article V., Limitations

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III herein. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the internal revenue code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article VI., Dissolution

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
