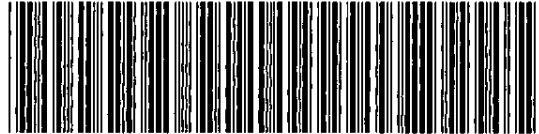

**I.**

The name of the Corporation is **Urbieto Family Fund For Colon Cancer Research Foundation Inc. (the "Corporation")**

**II.**

The principal place of business of the corporation is **9701 NW 89 Ave, Medley, Florida 33178.**

**III.**

- This corporation is a nonprofit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Corporation Law for charity purposes.
- The specific purpose of the Corporation is to provide funding support through funding raising activities for post adjuvant chemotherapy treatment. Research is needed to identify the genetic and environmental factors that influence colorectal tumor recurrence. The long-term goal of the research is to develop novel strategies for the prevention of tumor recurrence in colorectal cancer patients.
- The Corporation is organized and operated exclusively for charitable purposes as noted above within the meaning of 501(c)(3) of the Internal Revenue Code of 1986(the "Code") or the corresponding provisions of any future United States internal revenue law.
- Notwithstanding any other provision of these articles, the Corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of any purpose of the Corporation, and the Corporation shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt from federal income tax under Section 501(c) (3) of the Code or the corresponding provisions of any future United States internal revenue law.




