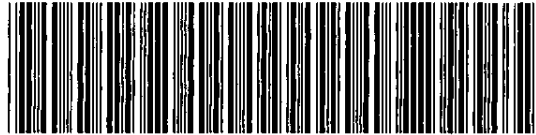

The name of the Corporation is Association of Sons and Friends of Perou Inc./a Non-Profit Organization

ARTICLE II – LOCATION/PRINCIPAL PLACE OF BUSINESS AND ADDRESS

The Principal office of this Corporation is located at 863 NW 109th Street, Miami, FL 33168.

ARTICLE III – PURPOSES

The particular objectives for which this non-profit corporation is formed are:




