

ARTICLE I - NAME

The name of the corporation shall be: HARBOR HOUSE ABUNDANT LIFE MINISTRY, INC.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE

The purpose for which the corporation is organized shall be church worship and church related activities and all things in connection therewith that are related under the laws of the State of Florida. The business of the corporation shall be limited to the foregoing activities.




