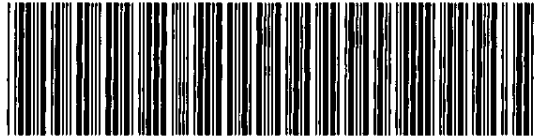

**ARTICLES OF INCORPORATION
OF

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following articles of incorporation:

ARTICLE I NAME

The name of the corporation shall be ACLARIS CAREER CORPORATION.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:
1710 W. KIRBY STREET, TAMPA, FL 33604

ARTICLE III MISSION STATEMENT

To provide vocational rehabilitation and job opportunities for the physically challenged.

ARTICLE IV VISION

To access the serviceability of Community to provide vocational training and rehabilitation to the physically challenge that would enable suitable employment.

ARTICLE V – INITIAL BOARD OF DIRECTORS

The initial board of directors are Miguel Albizo, 1710 W. Kirby St, Tampa, FL 33604, and Clarisvel Albizu, 1710 Kirby, St., Tampa, FL 33604.

ARTICLE VI MANNER OF ELECTION OF DIRECTORS

The board of directors shall be appointed and the members shall elect its officers.

ARTICLE VII INITIAL REGISTERED AGENT AND STREET ADDRESS

The name and Florida Street address of the initial registered agent is: Clarisvel Albizu, 1710 W. Kirby Street, Tampa, FL 33604.

ARTICLE VIII – DISTRIBUTIONS AND DISSOLUTIONS

Section A – Said organization is organized exclusively for charitable, religious, education, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Section B – No part of the net earnings of the organization shall inure to the benefit of, or be distributed to its members, trustees, officers, or private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future tax code, or (b) by an organization, contributions to which are deductible under section of 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Section C – Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for public purpose. An such assets not disposed of shall be disposed of by the Court of common Pleas of the county in which the principal office of the organization is then located exclusively for such purposes or such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE IX – INCORPORATOR
