**ARTICLES OF INCORPORATION
OF
MORE LIFE, INC.**

ARTICLE I.

The name of the corporation shall be: More Life, Inc.

ARTICLE II

The principal place of business and mailing address of this corporation shall be:
328 Hammock Grove Court, Saint Johns, Florida 32259.

ARTICLE III

This corporation is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV

The three original directors of this corporation shall be:

Jeffrey M. Brandner, 13724 Shady Woods St. N., Jacksonville, Florida 32224;
Jason M. Brandner, 13724 Shady Woods St. N., Jacksonville, Florida 32224;
Lyle G. Sjomeling, 328 Hammock Grove Court, Saint Johns, Florida 32259.

Thereafter, if a director position becomes vacant the remaining director or directors shall unanimously appoint each successor. The three directors shall have the power to expand the board of directors to nine directors upon a unanimous vote of the three. Directors shall govern the operations of the corporation by a unanimous vote of all directors present at a duly called and noticed meeting.

ARTICLE V

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III above. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or

distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE VI

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE VII

ARTICLE VIII
