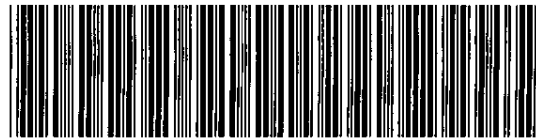

Articles of Incorporation
Generation Next, Inc.
A Nonprofit Corporation
In Compliance with Chapter 617, F.S.

Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Nonprofit Law of Florida do hereby certify:

Article I: The name of the corporation shall be: Generation Next, Inc.

Article II: The principal place of business and mailing address is:

Brooksville, Florida 34601

Article III: The corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code. The specific purpose for which the corporation is organized is to empower today's youth with the knowledge, skills and experience to become the leaders of tomorrow. We are dedicated to inspiring passion, commitment and sense of purpose in our youth as they move forward enriching their communities.

Article IV: The Corporation shall have 3 directors. The manner in which the Directors are elected is provided for in the By-Laws.

Article VI: The name and address of the Registered Agent is:

Article VII: No part of the net earnings of the corporation shall inure to the benefit of or to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 3 hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of the corporation.

Article VIII: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are operated exclusively for such purposes.

Article IX: The Corporation shall not have members.


Article X: The period of duration of the corporation is perpetual.
