Section E – Amending or Adding additional Articles

Article VIII

Distribution of Assets upon Dissolution:

The organization is organized exclusively for charitable, religious, and/or educational purposes within the meaning of section 501(c)3 of the Internal Revenue Code.

Notwithstanding any other provision of these articles, the corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)3 of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue law).

Upon the dissolution of this corporation, assets will be distributed for one or more exempt purposes within the meaning of section 501(c)3 of the Internal Revenue Code (or corresponding section of any future federal tax code), or more specifically to the Community Arts Connection of South Lake, Inc. If the Community Arts Connection is no longer in existence the assets will be distributed to another tax-exempt charitable organization providing educational art opportunities for the community to be selected by the remaining directors. If a suitable organization is not found the assets shall be distributed to the Federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
