**ARTICLES OF INCORPORATION  
OF  
Story Book Meadows Incorporated**

**ARTICLE I**

The name of the corporation is: STORY BOOK MEADOWS INCORPORATED

**ARTICLE II**

The principal street and mailing address is:

**ARTICLE III**

- A. This corporation is a nonprofit PUBLIC BENEFIT CORPORATION and is not organized for the private gain of any person.
- B. The primary purpose shall be to provide a positive, safe and structured ranch environment for all people, particularly those in crisis, including emotional difficulties, terminally ill, disabled and disadvantaged.

**ARTICLE IV**

The manner in which directors are elected or appointed is by a majority vote of the existing directors.

**ARTICLE V**

- A. This corporation is organized and operated exclusively for charitable purposes within the meaning of Section 501(c)(3), Internal Revenue Code.
- B. No substantial part of the activities of the corporation shall consist of carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

## **ARTICLE VI**

The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for the public purpose. Any such assets not disposed of shall be disposed of by the Superior Court of the county in which the principal office of the organization is then located, exclusively for the purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

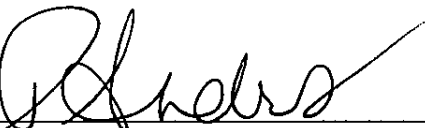
