Attachment to the Articles of Amendment

ARTICLE VIII - DURATION AND DISSOLUTION

The Corporation shall exist perpetually until dissolved. Upon dissolution, the Corporation's assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding sections of any future federal tax code, or shall be distributed to the federal government, or to the state or local government, for a public purpose.
