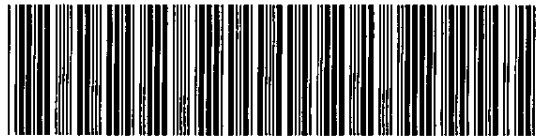

ARTICLE III.

The purposes for which the corporation is organized are: The corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt of organizations under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

The primary purpose of this organization is to operate a church and to perform all related acts and services in regard to operating a church including the purchases of real estate and personal property executing encumbrances against said property in the form of deeds of trusts, bonds and otherwise to lease and to otherwise deal in any legal way with their personal and real property.

The purposes of this corporation are more clearly expressed in the Biblical verses Acts 1:8 and Matthew 28:19-20: "Ye shall be witnesses unto me both in Jerusalem and in all Judea and in Samaria and unto the uttermost parts of the earth". That this corporation shall have as its purpose the organization of churches in all states of the United States and in all parts of the world.
