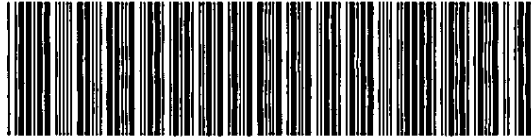



## SUNSHINE FLY ANGLERS, INC., DETAILS OF PLAN OF DISTRIBUTION OF ASSETS

This document is prepared for the purpose of providing the details of the distribution plan agreed to by the Board of Directors and the Membership.

Sunshine Fly Anglers, Inc., a Florida Not for Profit Corporation, FEI # 26-3722049, having its principal mailing office at P.O. Box 1984, Lady Lake, FL 32159, filed for dissolution on January 11, 2016, with the State of Florida, Department of State. (Sunshine Fly Anglers, Inc. is a regional extension of International Federation of Fly Fishers Inc. ("IFFF"), a 501(c)(3) organization, EIN # 23-7037444).

Pursuant to Florida Statute 617.1406, The Sunshine Fly Anglers, Inc. submits details to the Plan of Distribution of Assets consistent with the Articles of Incorporation and Bylaws. The Board of Directors adopted a resolution recommending a plan of distribution and directed its submission to a vote at a meeting of members entitled to vote thereon at a special meeting on January 11, 2016. The plan was adopted by receiving a majority of the votes of the members present at a meeting on January 15, 2016.

All liabilities and obligations of the corporation have been paid and discharged.

Assets held by the corporation upon condition requiring return, transfer, or conveyance, which condition occurs by reason of the dissolution, have been returned or conveyed in accordance with such requirements. The assets, including eleven rods and reels, one reel case, six Dan vices, each with a tool kit, and one 10'x10' tent, were transferred to The Florida Council, a regional extension of the International Federation of Fly Fishers Inc., EIN # 23-7037444, having its principal office at 5237 U.S. Highway 89 South, Suite 11 Livingston, Montana 59047, on behalf of the International Federation of Fly Fishers Inc., on February 10, 2016.

Assets received and held by the corporation subject to limitations permitting their use only for charitable, religious, eleemosynary, benevolent, educational, or similar purposes, but not held upon a condition requiring return, transfer, or conveyance by reason of the dissolution, are to be transferred or conveyed to two domestic organizations, listed below, that are engaged in activities substantially similar to those of the dissolving corporation.

These assets include \$3,695.77 cash and shall be distributed as follows:


