Article X.- Members, officers, volunteers, and employees of this corporation shall respect a conflict of interest policy to protect its interest when it is contemplating entering into a transaction or arrangement that might benefit the private interest of an officer or director of the Organization or might result in a possible excess benefit transaction.

This policy is to be defined in a document to be voted by the board and which copy to be distributed and signed by all new members, officers, employees and volunteers.
