**ARTICLES OF INCORPORATION  
OF  
JEWISH RECOVERY CENTER INC.**

The undersigned, acting as Incorporator of a Florida corporation under the Florida Not For Profit Corporation Act, Chapter 617 of the Florida Statutes, hereby causes to be delivered the following Articles of Incorporation:

**ARTICLE I  
NAME**

The name of the corporation shall be Jewish Recovery Center Inc. (hereinafter, the "Corporation").

**ARTICLE II  
PRINCIPAL OFFICE AND MAILING ADDRESS**

The street address of the principal office and the mailing address of the Corporation is 4923 Rabbit Hollow Drive, Boca Raton, FL 33487.

**ARTICLE III  
PURPOSE**

The Corporation is organized not for pecuniary profit, but a charitable organization intended to qualify under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended ("Code"), and no distribution of assets of the Corporation shall be made upon dissolution except to an entity which is exempt from taxation pursuant to Section 501(c)(3) of the Code. In furtherance of the purposes of the Corporation, and within the foregoing restrictions, the Corporation shall have all lawful powers necessary or appropriate to such purposes, including but not limited to providing support for individuals in recovery of drug or alcohol abuse and all corporate powers corporations may have under the Florida Not For Profit Corporation Act, as it may be amended or replaced from time to time, or the provisions of any similar law.

**ARTICLE IV  
APPOINTMENT OF DIRECTORS**

The manner in which directors are elected or appointed shall be stated in the Corporation's Bylaws.
