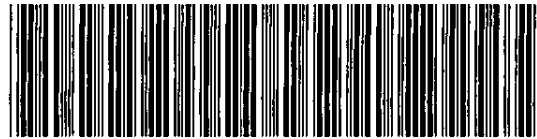

The purpose for which the corporation is organized is:

The manner in which the directors are elected or appointed:

After the inaugural appointment of directors, a meeting will be held annually to hold elections. Candidates may volunteer or be nominated by the current board. Directors will be elected by a clear majority. In the event of a tie, the current President will have the deciding vote. If at any time no new candidates are available the board is to remain unchanged. Upon the mid-term resignation of a board member the current President may unilaterally appoint their replacement.
