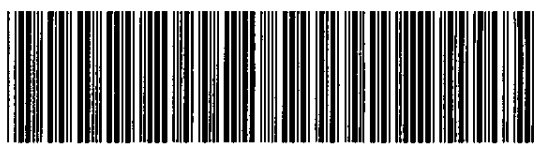




- A. The corporation is organized and operated exclusively for the purposes set forth in Article VI herein.


