The undersigned incorporate, for the purpose of forming a corporation under the Florida Not for Profit Act; hereby adopt(s) the following Articles of Incorporation:

#### ARTICLE I - NAME

#### ARTICLE III - PURPOSE(S)

The specific purpose(s) for which the corporation is organized is:

To provide Youth Services and Humanitarian Outreach working in association with **Estrela da Esperança Internacional – Brasil know as Star of Hope – Brazil** which has been originated from social work of **Star of Hope International - Sweden**, and also, said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### **ARTICLE IV - MANNER OF ELECTION OF DIRECTORS**

In accordance with section 617-0202(d) Florida Statutes:

The board of directors of the corporation shall have an Annual Business Meeting in which the directors are appointed and elected by vote. The affirmative votes of a number of directors at the time of this meeting must be equal to a majority of the number who constitute the full board of directors. The directors elected should have their mandate in force until the take over of the new director in the next Annual Business Meeting.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue-Gode, or the corresponding section of any future federal tax code.

### **ARTICLE XII - DISSOLUTION**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
