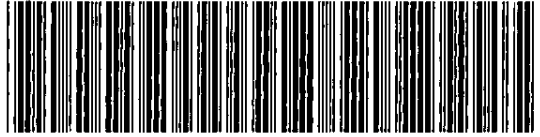

**ARTICLES OF INCORPORATION  
OF  
IDOLS ASIDE MINISTRIES, INC.**

The undersigned incorporators, for the purpose of forming a corporation under the Florida Not For Profit Corporations Act, hereby adopt the following Articles of Incorporation.

**ARTICLE I  
NAME**

The name of the corporation shall be: **IDOLS ASIDE MINISTRIES, INC.**

**ARTICLE II  
PRINCIPAL PLACE OF BUSINESS**


