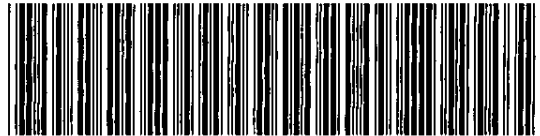

ARTICLE III- PURPOSE

1. Voice 4 Hope, Inc.'s mission is to renew hope by bringing help to those silenced by poverty, illiteracy and disease through responsible partnerships and sponsorships around the world. Voice 4 hope is an organization with a vision to restore hope in the lessen world, hope that change is not coming rather hope is here. Our goal is to meet the basic needs of those forgotten by the world, child, young and old regardless of race and religion. We want to provide food, clean water, shelter, and clothes for those in needs and empower them through many programs well-planned. We want to offer our services by attacking poverty at its core, bringing education to the illiterate thus helping them to acquire the tools needed for an uplifting life through honest work. We want to build health clinics to promote basic medical needs such as prenatal care, provide vaccinations, flu shots, and to teach disease prevention such as HIV, Aids, Hepatitis B, TB and sexual transmitted diseases. We want to do wellness promotion by teaching the importance of exercise, proper diet, and good sanitation.
2. No substantial part of the activities of the corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in, any political campaign on behalf of any candidate for public office.
3. The Corporation is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as an exempt organization under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE VIII- DISSOLUTION

1. The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person.
