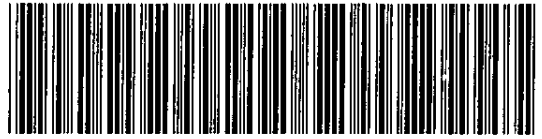

ARTICLES OF INCORPORATION
OF

The undersigned acting as incorporators of a corporation pursuant to Florida Corporations Law Statutes governing non-profit corporations, adopts the following Articles of incorporation.

ARTICLE I
NAME

ARTICLE II
PRINCIPLE PLACE OF BUSINESS AND MAILING ADDRESS

PURPOSES

1. To provision of transitional housing for the economically and socially disadvantaged such as the, elderly, homeless, and veterans.
2. To serve as a community outreach agency providing services to the socially and economically disadvantaged of the community at large.
3. To spread the Christian doctrine of Jesus Christ as a faith based organization.
4. To serve as a Christian Church.
5. To operate as a Christian educational institution providing Christian study.
6. To operate exclusively for charitable, religious, and educational purposes within the meaning of 501 (c) (3) of the Internal Revenue Code of 1986 or any corresponding provision of any future United States Internal Revenue Law.

ARTICLE IV DISSOLUTION

Upon dissolution of the corporation as an act of law or by resolution of the Board of Directors assets of the corporation shall be distributed to a non profit 501 (c) (3) corporation. "However" if the named recipient is not in existence as a distributee, or is unwilling to accept the distribution, the assets shall be distributed to a fund, foundation, or organization which operates exclusively for purposes specified in section 501 (c) (3) of the Internal Revenue Code of 1986 or any future Internal Revenue Law.

ARTICLE V POWERS

Notwithstanding any other provision of these articles, the organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code or any corresponding provision of any futures Internal Revenue Law.

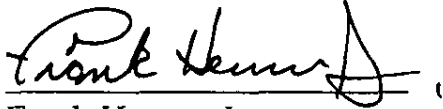
