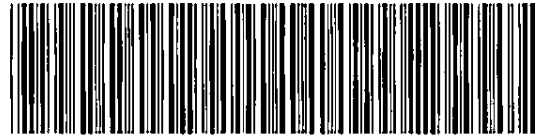

The new directors nominated:

Leslie Fenderigos, retired Florida attorney residing in the greater Orlando area and an advocate for people with disabilities including autism;

Luanne Feming and Robin Austin, are strong media advocates supporting people with disabilities and elders with their national talk show.

Debra Vanpatten, parent advocate, provides knowledge regarding services for people with autism to enhance their life including job coaching, speech therapy, educational opportunities, social aspects of their life and parent advocacy in the legal system.

All voted and approved.

After discussion the following mission goals were accepted:

Create a pilot program with a veterinarian to have service dogs trained to work with people with autism.

Offer volunteers in autism private schools.

Provide legal advocacy for autism.

Fundraising activities projected: Sonny's Barbeque, Concert in the Park, application for grants, donations through social media.

Services provided speech therapy, behavioral therapy, job coaching, social events for people with autism

It was voted and agreed to change the name and address from Creative Living, Inc. to Autism Support Services Advocacy, Inc. with the acronym being ASSA with the Articles of Incorporation and register with the new name and address change with SUNBIZ, org.

The last item on the agenda is the resignation of Bonnie Carter as a director. She reported that in 2024 Creative Living, Inc. contributed a \$1,000 donations to ARC, Americans for Retarded Citizens National Work Program, DeLand location, Sanford Herald newspaper

article was published on the story april 4 2024 with Carter's request for matching funds donations to ARC
