



ARTICLE V Purposes

The Corporation is organized and shall be operated exclusively for one or more of the purposes as specified in <u>Section 501(c)(3)</u> of the Internal Revenue Code of 1986, as amended (the "Code"), including:

To provide a support organization and a forum for collective research, education, development, dissemination, implementation, promotion, advancement, adoption and integration of sustainability practices by local farms, restaurants, hotels and other members of the agriculture and hospitality industries, through educational workshops, demonstrative pilot projects, outreach events, and the development of technologies and tools for members, local governments, schools, and other non-profits and charitable organizations that seek to capitalize on group synergies, encourage economic development through local investment, and encourage the widespread utilization of high-quality, sustainably produced and locally sourced foods and other products and services, as well as of best practices for environmental and waste management, through increased public awareness of the long-term societal and economic benefits.

The purposes for which the corporation is organized are further as set forth below:

- 1. To research, collect and disseminate information on the social, ecological and economical benefits of sourcing environmentally preferable products and local, sustainable, and organic farm products and/or services;
- 2. To provide an educational forum for the exchange of information that will improve the quantity, quality and marketability of sustainable and organic, locally-sourced farm products and/or services;
- To facilitate localized connections between members of the farming community and hospitality industry and other interested organizations who are committed to utilizing, improving and promoting sustainability and environmental and waste management best practices;
- 4. To provide educational and technological tools and programs to schools, local governments, other non-profit organizations and consumers to aid in the procurement of healthy, locally-sourced, sustainable and organic foods with a particular aim of lessening the burdens of government.
- 5. To develop pilot projects, which may include the acquisition of property, that aim to prove the economic feasibility of producing and sourcing sustainable and organic foods, products and services. (Note, however, that property to be acquired will primarily be limited to those that are located within areas and census tracts that are either environmentally sensitive or economically stressed, particularly deteriorated urban properties that have fallen into misuse.)
- 6. To raise funds through all available sources in order to seed programs and projects that more effectively link sustainable producers with end users and consumers and other stakeholders, including those that establish and promote communication and interaction between members, consumers, distributers and other stakeholders, that catalyze group synergies, that promote local markets, community events and conferences and that otherwise aid in addressing the needs and objectives of the members;
- 7. To design, support or facilitate the creation and implementation of an authentic, reliable, uniform, industry-standard audit and certification program which will aim to help ensure that such certified products and services are local and sustainable;
- 8. To maintain relationships and liaison with educational institutions, research institutes, governmental entities or other organizations that support and contribute to ever more sustainable agriculture and hospitality industries and to sustainable development;
- 9. To generally advocate for legislative changes to promoting sustainability in agriculture, hospitality and environmental and waste management;

- 10. To foster competition in the development and use of more locally-sourced, environmentally preferable and sustainable products and services in conformance with all applicable antitrust laws and regulations as well as more efficient use of natural resources and minimization and/or reuse of waste bi-products throughout the agricultural and hospitality industries.
- 11. To establish, grow and manage a national network of local chapters that further the goals set forth above.
- 12. To undertake any other proper purpose of a not for profit corporation.
