

Articles of Incorporation of

The Britany of Normandy Square Condominium Association, Inc. ia Florida corporation not for profit)

MERITAN STATE OF STAT In order to form a corporation not for profit under the laws of the State of Florida, we, the undersigned, do bureby associate ourselves into a corporation for the purposes herein apocified and to that end we do by these Artisles of Incorporation set forth:

ARTICLE I

The name of the corporation shall be The Brittany of Normandy Square Condominium Association, Inc., hurrinafter referred to as the "Association".

ARTICLE II

. The purpose and objectives of the Association shall be to administer the operation and management of The Britishy of Normandy Square Condominium, (the "Condominium") in accordance with the Florida Condominium Act (the "Act") upon land situated in Broward County, Florida, in accordance with the rights reserved by Developer as contained in the Declaration of Condominium of The Brittany of Normandy Square Condominium, recorded in the Public Records of Broward County, Florida and to perform the acts and duties incident to the administration, operation and management of such condominium in accordance with the terms, provisions, conditions and authorizations of these Articles of Incorporation, the Bylaws of the Association to be adopted (the "Bylawe") and in the formal Declaration of Condominium (the "Declaration") which will be recorded in the Public Records of Broward County, Florida, when the laud and the improvements constructed thereof are submitted to the condominium form of ownership; and to operate, encumber, lease, manage, convey, trade and otherwise deal with the land, the improvements and such other property, whether real and/or personal, as may be or become part of the Condominium (the "Condominium Property") to the extent necessary or convenient in the administration of the Condominium. The Association shall be conducted as a non-profit organization for the benefit of its members.

ARTICLE M

The powers of the Association shall include and be governed by the following provisions:

- All of the powers and privileges granted to corporations not for profit under the laws pursuant to which this corporation is chartered.
- B. All of the powers reasonable and necessary to implement and effectuate the purposes of the Association, including, without limitation, the power, authority and right to:
 - Make and establish reasonable rules and regulations governing use of the units, common elements and limited common elements in and of the Condominium as such terms are defined in the Declaration.
 - 2. Power to Manage Condominium Property and to Contract, Sue, and Be Sued.—'The association may contract, sue, or be sued with respect to the exercise or nonexercise of its powers. For these purposes, the powers of the association include, but are not limited to, the maintenance, management, and operation of the condominium property. The association may institute, maintain, settle, or appeal actions or hourings in its name on behalf of all unit owners concerning matters of common interest to most or all unit owners.
 - Assessments; Management of Common Elements.—The association has the
 power to make and collect assessments and to lease, maintain, repair, and
 replace the common elements.
 - 4. Right of Access to Units.—The association has the irrevocable right of access to each unit during reasonable hours, when necessary for the maintenance, repair, or replacement of any common elements or of any portion of a unit to be maintained by the association pursuant to the declaration or as necessary to prevent durings to the common elements or to a unit or units.
 - 5. Title to Property.
 - a) The association has the power to acquire title to property or otherwise hold, convey, lesse, and morgage association property for the use and benefit of its members. The power to acquire personal property shall be exercised by the board of administration.
 - b) Subject to the provisions of s. 718, 112(2)(m), the association, through its board, has the limited power to convey a portion of the common elements to a condemning authority for the purposes of providing utility ensements, right-of-way expansion, or other public purposes, whether negotiated or as a result of eminent domain proceedings.

- Purchase of Leases.—The association has the power to purchase any land or recreation lease upon the approval of the voting interest.
- 7. Purchase of Units.—The association has the power to purchase units in the condominium and to acquire and hold, lease, mortgage, and convey them. There shall be no limitation on the association's right to purchase a unit at a foreclosure sale resulting from the association's foreclosure of its lien for unpaid assessments, or to take title by deed in lieu of foreclosure.
- 8. Basements.— The board of administration has the authority, without the joinder of any unit owner, to grant, modify, or move any easement if the easement constitutes part of or crosses the common elements or association properly. This subsection does not authorize the board of administration to modify, move, or vacate any easement created in whole or in part for the use or benufit of anyone other than the unit owners, or crossing the property of anyone other than the unit owners, without the consent or approval of those other persons having the use or benefit of the casement, as required by law or by the instrument creating the easement. Nothing in this subsection affects the minimum requirements of Florida Statute 718.104(4)(a) or the powers enumerated in subsection (3).

9. Insurance.-

- a) A unit-owner controlled association shall use its best efforts to obtain and maintain adequate insurance to protect the association, the association property, the common elements, and the condominium property required to be insured by the association. If the association is developer controlled, the association shall exercise due diligence to obtain and maintain such insurance. Failure to obtain and maintain adequate insurance during any period of developer control shall constitute a breach of fiduciary responsibility by the developerappointed members of the board of directors of the association, unless said members can show that despite such failure, they have exercised due diligence.
- Bvery hazard insurance policy shall provide primary coverage for:
 - (1) All portions of the Condominium property located outside the unit;
 - (2) The Condominium property located inside the units as such property was initially installed, or replacements thereof, of like kind and quality and in accordance with the original plans

and specifications or, if the original plans and specifications are not available, as they existed at the time the unit was initially conveyed; and

- All portions of the Condominium property for which the declaration requires coverage. Anything to the contrary norwithstanding the terms "Condominium property," "Building," "unprovements," "insurable improvements," "common elements," "association property" or any other term found in the Declaration of Condominium which defines the scope of property or casualty insurance that a condominium association must obtain shall exclude all floors. walls, and ceiling coverings, electrical fixtures, appliances, air conditioners or heating equipment, water heaters, water filters, built in cabinets and counter tops, and window treatments, including curtains, drapes, blinds, hardware, and similar window treatment compounts, or replacements of any of the foregoing which are located within the boundaries of a unit and surve only one unit and all air conditioner compressors that service only an individual unit whether, or not located within the unit boundary, the foregoing is intended to establish the property or casualty insuring responsibility of the association and those of the individual unit owners and do not serve to broaden or extend the perils of coverage afforded by any insurance contract provided to the individual unit.
- (c) Every hezard insurance policy issued or renewed to an individual unit owner shall provide the coverage afforded, by such policy is excess over the amount recoverable under any other policy covering the same property. Each insurance policy issued to an individual unit owner providing such coverage shall be without the rights of subnegation against the condominium association that operates the condominium in which such unit owners unit is located. All real or persunal property located within the boundaries of the unit owner's unit which is excluded from the coverage to be provided by the association shall be insured by the individual unit owner.
- (d) The association shall obtain and maintain adaquate insurance or fidelity bonding of all persons who control or disburse funds of the association. The insurance policy or fidelity bond must cover the maximum funds that will be in the custody of the association or its management agent at any one time. As used in this paragraph, the term "persons who control or disburse funds of the association"

includes, but is not ilmited to, those individuals authorized to sign checks and the president, secretary, and treasurer of the association. The association shall beer the cost of bonding.

- Enforce the provisions of these Articles of Incorporation, the Declaration, the Bylaws and all rules and regulations governing use of the Condominium which may from time to time be established.
- Exercise, undertake and accomplish all of the right, duties and obligations
 which may be granted to or imposed upon the Association in the Declaration
 and the Condominium Statutes.
- 12. The bylaws shall include a provision granting the association a limited power to convey a portion of the common element to a condemning authority for the purposes of providing utility easements, right-of-way expansion, or other public purposes, whether negotiated or as a result of eminent domain proceedings.

ARTICLE IV

The quali fication of members, the manner of their admission to and termination of membership and voting by members shall be as follows:

- A. The Developer shall be a member of the Association as long as the developer awas units in the association. The record owners of all units in the Condomicium shall be members of the Association and no other persons or entities shall be entitled to membership, except as provided in Paragraph E, Article IV, hereof.
- B. Membership shall be established by the acquisition of legal title to a unit in the Condominium or in added units or by acquisition of a fee ownership intexest therein, by voluntary conveyance or operation of law and the membership of any person or entity shall be automatically terminated when such person or entity is divested of all title or his entire lice ownership in such unit, provided however that, nothing herein contained shall be construed as terminating the membership of any person or entity owning for title to or a fee ownership interest in two or more units at any time while such person or entity shall retain fee title to or a fee ownership interest in any unit.
- C. The interest of a member in the funds and assets of the Association cannot be essigned, hypothecated or transferred in any mannor, except as an appartenance to the unit owned by such member. The funds and assets of the Association shall be held or used only for the benefit of the membership and for the purposes authorized barein, in the Declaration and in the Bylaws.

- D. On all matters upon which the membership shall be antitied to vote, there shall be one vote, and only one vote, for each unit in the condominium, which vote may be exercised or east by the owner of each unit as may be provided in the Bylaws of the Association. Should any person or eatity own more than one unit, such member shall be entitled to exercise or east one vote for each such unit in the manner provided by the Bylaws.
- E. Until such time is the land and the improvements constructed thereon are submitted to the condominium form of ownership by recordation of the Declaration in the Public Records of Broward County, Plotida, the membership of the Association shall be comprised of the subscribers to these Articles each of whom shall be entitled to cast one vote on all matters on which the membership shall be entitled to vote.

ARTICLE V

The term of the Association shall be perpetual or if the condominium is terminated, the term shall end as soon after termination of the condominium as its affairs can be concluded.

ARTICLE VI

The principal office of the Association shall be located in Florida. The affairs of the Association shall be managed by the Board of Administration. The Board of Administration shall be comprised of three persons appointed by the Developer until such time as the Developer transfers control to the Association. After such an event occurs, the Board of Administration shall be comprised of five persons. The members of the Board of Administration shall be elected by the members of the Association at the annual meeting of the membership as provided by the Hylaws. The method of election of directors is stated in the Bylaws. The Board of Administration was employ a managing agent, agently and/or other managerial and the Board of Administration and the affairs of the Association and any and all such persons and/or emittee may be so employed without regard to whether any such person or entity is a member of the Association or a member of the Board of Administration or officer of the Association, as the case may be.

The Board of Administration shall have a President, a Secretary and a Treasurer, and if so decided one or more assistants to such offices. The officers of the Association shall act subject to the direction of the Board of Administration and shall be elected by a majority of the Board of Administration. The President shall be elected from the membership of the Board of Administration but no other officer need be a member of the Board of Administration. The same person may hold two offices.

The Developer shall have the right to maintain control of the Association subject to the provisions of the Condominium Act and considering the fact that this Association is created for the purposes of operating and managing the condominium property.

ARTICLE VIL

The name and address of the members of the first Board of Administration, who subject to the provisions of the laws of the State of Florida, these Articles of Incorporation and the Bylaws, shall hold office until their successors are elected pursuant to provisions and procedures set forth in the Bylaws, and take possession, are as follows:

The subscribers to these Articles of Incorporation are the persons herein named to act and serve as members of the first Board of Administration of the Association. The names of the subscribers and their addresses are set forth in Article VII hereof.

ARTICLE VIII

The officers of the corporation who shall hold office until their successors are elected pursuant to these Articles of Incorporation and the Bylaws shall be the following:

PRESIDENT: Luis Cardonau SECRETARY: Luis Gonzaluz TREASURER: Francis Hawley

ARTICLE IX

The original Bylaws of the Association shall be adopted by a majority of the subscribers to those Articles of incorporation at a meeting at which a majority of the subscribers are present.

ARTICLE X

Every member of the Board of Administration and every officer of the Association shall be indemnified by the Association against all expenses and liabilities, including counsel fees, reasonably incurred by or imposed upon him in connection with any proceeding or any settlement

of any proceeding to which he may be a party, or in which he may become involved by reason of his being or having been a member of the Board of Administration or officer of the Association, whether or not he is a Board of Administration or officer at the time such expenses are incurred, except in such cases wherein the member of the Board of Administration or officer is adjudged guilty of willful misfeasance or malianamore in the performance of his duties; provided that, in the event of any claims for reimbursement or indemnification hereunder based upon a settlement by the member or officer seeking such reimbursement or indemnification, the indemnification herein shall apply only if the Board of Administration approves such settlement and reimbursement as being for the set interest of the Association. The foregoing right of indemnification shall be in addition to and not exclusive of all other rights which such member or officer may be entitled. The Association shall carry errors and omission insurance in favor of officers and members of the Board of Administration.

ARTICLE XI

An amendment or amendments to these Articles of Incorporation may be proposed by the Board of Administration or the Association setting upon a vote of the majority of the members, or by the members of the Association owning a majority of the units in the condominium at the time declared or added, whether meeting as manbers or by instrument in writing signed by them. Upon any amendment or amendments to these Articles of Incorporation being proposed by the Board or member, such proposed amendment shall be transmitted to the President of the Association or the acting Chief Executive Officer in the absence of the President, who shall thereupon call a special meeting of the membership for a date not sooner than twenty days or later than sixty days from the receipt by him of the proposed amundment, and it shall be the duty of the Secretary to provide each member written notice for such meeting stating the time and place of the meeting and reciting the proposed amendments in reasonable detailed form which notice shall be mailed or presented personally to each member not less than fourteen days nor more than thirty days before the date set for such meeting. If mailed, such notice shall be deemed properly given when deposited in the United States mail, addressed to the member at his post office address as it appears on the records of the Association with postage thereon prepaid. Any member may, by written waiver of notice signed by such member, waive such notice and such weiver when filed in the records of the Association whether before, during or after the holding of the meeting, shall be deemed equivalent to the giving of such notice to such member. At such meeting the amendment proposed must be approved by an affirmative vote of the member owning not less than two-hirds of the units in the condominium in order for such amendment to become effective. Thereupon, such amendments of these articles of incorporation shall be transcribed and certified in such form as may be necessary to file the same in the office of the Secretary of the State of Florida. A certified copy of each such amendment shall be recorded in the Public Records of Broward County, Florida within thirty days from the date on which the same is filed to the office of the Secretary of State. No Amendment is valid unless recorded with identification on the first page thereof of the book and page of the public records where the declaration of each condominium operated by the Association is recorded.

ARTICLE XII

When unit owners other than the developer own 15 percent or more of the units in a condominium that will be operated ultimately by an association, the unit owners other than the developer shall be entitled to elect no less than one-third of the members of the board of administration of the association. Upon the election of such director, the developer shall forward to the Division of Florida Land Sales Condominium and Mobile Homes the name and mailing address. of the directors elected. Unit owners other than the developer are entitled to elect not less than a majority of the members of the board of administration of an association; Three years after 50 percent of the units that will be operated ultimately by the association have been conveyed to purchasers; Three months after 90 percent of the units that will be operated ultimately by the association have been conveyed to purchasers:(u) When all the units that will be operated ultimately by the association have been completed, some of them have been conveyed to purchasers, and none of the others are being offered for sale by the developer in the ordinary course of basiness; (b) When some of the units have been conveyed to purchasers and none of the others are being constructed or offered for sale by the developer in the ordinary course of basiness; (e) 120 days after the date by which 75 percent of the units have been conveyed to unit purchasers; or (d) Seven years after recordation of the declaration of condominium, which over occurs first at such time the declarant shall relinquish all special rights, expressed or implied, through which the declarant may directly or indirectly control, direct, modify, or veto any action of the owners association, its executive board, or a majority of unit owners, and control of the owners association shall pass to the owners of units within the project.

The Developer may transfer control of the Association to the Unit Owners other than the Developer prior to such dates in its sole discretion by causing enough of its appointed Directors to resign, whereupon it shall be the affirmative obligation of the Unit Owners other than the Developer to elect Directors and assume control of the Association. Provided at least thirty (30) days' notice of the Developer's decision to cause its appointees to resign is given to the Unit Owners, neither the Developer nor such appointees to resign is given to Unit owners, neither the Developer, nor such appointees to resign is given to Unit owners, neither the Developer, nor such appointees shall be liable in any transact in connection with such resignation even if the Unit Owners other than the Developer refuse or fail to assume control.

Within 75 days after the unit owners other than the developer are entitled to elect a member or members of the board of administration of an association, the association shall call, and give not less than 60 days notice of an election for the members of the board of administration. The election shall proceed as provided in a. 718.112(2)(d). The notice may be given by any unit owner if the association falls to do so. Upon election of the first unit owner other than the developer to the board of administration, the developer shall forward to the division the name and mailing address of the unit owner board member.

 If a developer holds units for sale in the ordinary course of business, none of the following actions may be taken without approval in writing by the developer:

- Assessment of the developer as a unit owner for capital improvements.
- Any action by the association that would be detrimental to the sales of units by the developer. However, an increase in assessments for common expenses without discrimination against the developer shell not be deemed to be detrimental to the sales of units.
- 2. At the time that unit owners, other than the developer, elect a mejority of the members of the board of administration of an association, the developer shall relinquish control of the association, and the unit owners shall accept control. Simultaneously, or not more than 90 days thereafter, the developer shall deliver to the association, at the developer's expense, all property of the unit owners and of the association which is held or controlled by the developer, including, but not limited to, the following items, if applicable, as to each condomatium operated by the association:
 - a) The original or a photocopy of the recorded declaration of condominium and all amendments thereto. If a photocopy is provided, it shall be cartified by affidavit of the developer or an officer or agent of the developer as being a complete copy of the second recorded declaration.
 - b) A certified copy of the articles of incorporation of the association or, if the association was created prior to the effective date of this act and it is not incorporated, copies of the documents creating the resociation.
 - c) A copy of the bylaws.
 - The minute books, including all minutes, and other books and records of the association, if any.
 - Any house rules and regulations which have been promulgated.
 - f) Resignations of officers and members of the board of administration who are required to resign because the developer is required to relinquish control of the association.
 - g) The financial records, including financial statements of the resociation, and source documents from the incorporation of the resociation through the date of turnover. The records shall be sudited for the period from the incorporation of the association or from the

period covered by the last audit, if an audit has been performed for each fiscal year since incorporation, by an independent certified public accountant. All financial statements shall be prepared in accordance with generally accepted accounting principles and shall be audited in accordance with generally accepted auditing standards, as prescribed by the Florida Beard of Accountancy, pursuant to sthepter 473. The accountant performing the audit shall extanded to the extent necessary supporting documents and records, including the each disbursaments and related paid invoices to determine if expenditures were for association purposes and the billings, each receipts, and related records to determine that this developer was charged and paid the proper amount of assessments.

- h) Association funds or control thereof.
- All tangible personal property that is property of the association, which is represented by the developer to be part of the common elements or which is estembly part of the common elements, and an unventory of that property.
- j) A copy of the plans and specifications utilized in the construction or remodeling of improvements and the supplying of equipment to the condominium and in the construction and installation of all mechanical components serving the improvements and the site with a certificate in affidavit form of the developer or the developer's agent or an architect or angineer authorized to practice in this state that such plans and specifications represent, to the best of his or her knowledge and belief, the actual plans and specifications utilized in the construction and improvement of the condominium property and for the construction and installation of the mechanical components serving the improvements. If the condominium property has been declared a condominium mer than 3 years after the completion of construction or remodeling of the improvements, the requirements of this paragraph do not apply.
- k) A list of the names and addresses, of which the developer had knowledge at any time in the development of the condominium, of all contractors, subcontractors, and suppliers utilized in the construction or remodeling of the improvements and in the landscaping of the condominium or association property.
- 1) Insurance policies.

- (Copies of any certificates of occupancy which may have been issued for the condominium property.
- n) Any other permits applicable to the condominium property which have been issued by governmental bodies and are in force or were issued within 1 year prior to the date the unit owners other than the developer take control of the association.
- All written warranties of the contractor, subcontractors, suppliers, and manufacturers, if any, that are still effective.
- A roster of unit owners and their addresses and telephone numbers, if known, as shown on the developer's records.
- q) Leases of the common elements and other leases to which the association is a party.
- Employment contracts or service contracts in which the association is one of the contracting parties or service contracts in which the association or the unit owners have an obligation or responsibility, directly or indirectly, to pay some or all of the fee or charge of the person or persons performing the service.
- All other contracts to which the association is a party.
