# ARTICLES OF INCORPORATION OF LAKE COUNTY 4-H FOUNDATION, INC.

The undersigned, acting as incorporators of a corporation under the Not for Profit Corporation Act of the state of Florida, adopt the following Articles of Incorporation for such corporation.

#### ARTICLE I

Name/Registered Office

The name of the corporation shall be: Lake County 4-H Foundation, Inc.

The corporation's registered office is located at: 1951 Woodlea Road, Tavares, Florida 32778

#### ARTICLE II

Purpose

This 4-H Foundation is formed for the following purposes:

- A. Secures resources to support the Lake County 4-H program in its effort to teach youth leadership, citizenship and life skills.
- B. To foster mental, physical, social, spiritual and all other aspects of youth development.
- C. To support Extension programs in the interest of youth as the Board of Directors of this 4-H Foundation may deem appropriate.
- D. In the event of the dissolution of the 4-H Foundation, all of its property, whether real, personal or mixed, and wheresoever situated shall invest immediately in the Lake County Extension Service for use in support of the Lake County 4-H Program.
- E. The corporation shall distribute its income, if any, for each taxable year at such time and such manner as not to become subject to tax on undistributed income imposed.
- F. To carry on any lawful activity not for pecuniary profit necessary or incidental to the attainment of the objectives of the 4-H Foundation.

#### **ARTICLE III**

Membership

There shall be 4 categories of members of the 4-H Foundation:

- 1. Membership—The membership of the Foundation shall consist of such persons as may, from time to time, be elected as board of directors, associate, honorary, friends, or life members, in accordance with the provisions hereinafter set forth.
- 2. Associate Members—Associate membership shall be granted for a period of one year to persons interested in the mission of the organization and willing to work toward its goals. A person may be nominated for Associate Membership by a member(s) of the Board of Directors and must receive a majority vote of the Board membership. Membership may be renewed by vote of the Board of Directors and agreement of the associate member. Associate members do not have voting privileges but may attend meetings of the organization.
- 3. Honorary Members—Honorary membership for a period of three (3) years may be given to persons who have made outstanding contributions to the Lake County 4-H Foundation or to the Lake County 4-H program. These members shall be selected by the Board of Directors with a majority vote.
- 4. Friends of the 4-H Foundation—Any person, organization, corporation, agency, or association interested in the objectives of the Foundation may become a Friend of the 4-H Foundation for the current year upon contribution to the Foundation. The Board of Directors reserves the right to refuse any contributions. The members first Board of Directors shall be comprised of the following persons:

This Corporation is to exist perpetually.

#### ARTICLE V

**Board of Directors** 

The lawful authority and power of this 4-H Foundation shall be exercised by, and its business shall be conducted and carried on by or authorized to be conducted and carried on by the Board of Directors, which shall not be less than fifteen (15) and not more than twenty-five (25) in number. In the event of a vacancy in the Board of Directors, the existing Board, by majority vote, shall appoint a replacement according to the By-Laws. Selection, duties and the qualification, manner and time of responsibilities of Said Board of Directors shall be published in the By-Laws.

## ARTICLE VI Officers

The 4-H Foundation shall have the following officers and shall be elected by the Board of Directors:

- 1. President
- 2. Vice President
- 3. Secretary
- 4. Treasurer
- 5. Parliamentarian

All officers must be a Director of the 4-H Foundation. The qualification, manner and time of selection, duties and responsibilities of said officers shall be published in the By-Laws.

#### **ARTICLE IX**

No part of the net earnings of this Corporation shall be distributed to, or inure to the benefit of, any member, trustee, or Officers of this Corporation, contributor or private individual.

In the event of dissolution, winding up, or other liquidation of the assets of this Corporation, its assets shall be distributed to the Lake County 4-H program.

## **ARTICLE X**

Debt Obligations and Personal Liability

No member, officer or Director of this corporation shall be personally liable for the debts or obligations of this corporation of any nature whatsoever, nor shall any of the property of the members, officers or Directors be subject to the payment of the debts or obligations of this corporation.
