

**ARTICLES OF INCORPORATION
OF
STICK IT GYMNASTICS PARENT ASSOCIATION, INC.**

The undersigned, acting as President of this Corporation pursuant to Chapter 617 of the Florida Statutes, hereby forms a corporation not for pecuniary profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such Corporation.

ARTICLE I – NAME OF CORPORATION

The name of this corporation is STICK IT GYMNASTICS PARENT ASSOCIATION, INC.

ARTICLE II – TERM OF EXISTENCE

This Corporation shall have perpetual existence.

ARTICLE III – PURPOSE

This Corporation is organized exclusively to promote the sport of gymnastics, and its purposes are exclusively religious, charitable, scientific, literary and educational within the meaning of Section 501(c)3 of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.


