ARTICLE I: NAME & PRINCIPAL OFFICE

The name of the corporation shall be:

J.I.R.E.H. International Outreach Ministries, Inc.

ARTICLE II:

EFFECTIVE DATE & CORPORATION EXISTENCE

The corporation existence shall commence effective **January 4, 2009** with filing with the Secretary of State. The period of its duration is perpetual, unless dissolved according to law.

ARTICLE III: PURPOSE

The general purposes for which this corporation is organized are exclusively religious, charitable, literary or educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Code. Without limiting the generality of the foregoing, J.I.R.E.H. International Outreach Ministries, Inc. is organized to act as a church/ministry for the sole purpose of proclaiming the Gospel of Jesus Christ in an effective and efficient manner as commanded by our Lord and Savior Jesus Christ in the Great Commission as referenced in the Holy Bible in Matthew 28:18-20 and Mark 16:15.

This corporation shall have the power to purchase, lease or otherwise acquire property, globally support missionaries and missions, raise funds, and do those things necessary to proclaim the Gospel in an adequate manner.

Notwithstanding any other provision of these articles, this organization shall not carry on any activity not permitted to be carried on by an organization exempt from Federal Income Taxes under Section 501(c)(3) of the Internal Revenue Code of 1986 or corresponding provision of any future United States Internal Revenue law.

ARTICLE IV:
DISSOLUTION OF ASSETS PROVISION

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Sections 501 (c) (3) and 170 (c) (2) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future law, or the Federal, State or local government for exclusive public purpose.

ARTICLE V:
MANNER OF ELECTION OF OFFICERS & INITIAL DIRECTORS/OFFICERS

The qualification for members and the manner of their admission are set forth in the Bylaws of the Corporation. The manner in which directors shall be appointed or elected and removal will be determined in the Bylaws.
