

ARTICLE VIII

NOTWITHSTANDING ANY OTHER PROVISIONS OF THESE ARTICLES, THE ORGANIZATION IS ORGANIZED EXCLUSIVELY FOR ONE OR MORE PURPOSES AS SPECIFIED IN SECTION 501(C)3 OF THE INTERNAL REVENUE CODE OF 1986, AND SHALL NOT CARRY ON ANY ACTIVITIES NOT PERMITTED TO BE CARRIED ON BY AN ORGANIZATION EXEMPT FROM FEDERAL INCOME TAX UNDER IRC 501(c)3 OR CORRESPONDING PROVISIONS OF ANY SUBSEQUENT TAX LAWS.

ARTICLE IX

NO PART OF THE NET EARNINGS OF THE ORGANIZATION WILL INURE TO THE BENEFIT OF ANY MEMBER, TRUSTEE, DIRECTOR, OFFICER OF THE ORGANIZATION, OR ANY PRIVATE INDIVIDUAL (EXCEPT THAT REASONABLE COMPENSATION MAY BE PAID FOR SERVICES TO OR FOR THE ORGANIZATION), AND NO MEMBER, TRUSTEE, OFFICER OF THE ORGANIZATION, OR ANY PRIVATE INDIVIDUAL SHALL BE ENTITLED TO SHARE IN THE DISTRIBUTION OF ANY OF THE ORGANIZATION'S ASSETS ON DISSOLUTION OF THE ORGANIZATION.

ARTICLE X

IN THE EVENT OF DISSOLUTION, ALL OF THE REMAINING ASSETS AND PROPERTY OF THE ORGANIZATION SHALL AFTER PAYMENT OF NECESSARY EXPENSES THEREOF BE DISTRIBUTED TO SUCH ORGANIZATIONS AS SHALL QUALIFY UNDER SECTION 501(c)3 OF THE INTERNAL REVENUE CODE OF 1986, OR CORRESPONDING PROVISIONS OF ANY SUBSEQUENT FEDERAL TAX LAWS, OR TO THE FEDERAL GOVERNMENT OR STATE OR LOCAL GOVERNMENT FOR A PUBLIC PURPOSE, SUBJECT TO THE APPROVAL OF A JUSTICE OF THE SUPREME COURT OF THE STATE OF FLORIDA.
